Le Quinze Vins Hong Kong 酒牌續期申請	同意續發為期 12 個月的酒牌，並修訂原有的附加持牌條件(a)項如下： 晚上 9 時至翌日上午 9 時，處所的所有門窗必須保持關閉。 並新增附加持牌條件(c)項如下： 持牌人須盡應盡的努力，確保售賣或供應的酒類飲品只供顧客在處所內飲用。 酒牌上原有的附加持牌條件(b)項則維持不變。
11 Westside Application for Renewal of Liquor Licence	Agreed to issue a 9-month liquor licence with the retention of existing additional licensing conditions.
