JALAN Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: (a) All doors and windows of the premises shall be kept closed between 9:00 p.m. and 9:00 a.m. the following day; (b) No liquor shall be sold or supplied for consumption on the premises between 1:00 a.m. and 9:00 a.m.; and (c) No consumption of liquor shall be allowed on the premises between 2:00 a.m. and 9:00 a.m.

	<p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
<p>Buddha Lounge Application for Amendment of Additional Licensing Conditions and Renewal of Liquor Licence</p>	<p>(i) Refused application for amendment of additional licensing condition (a) of liquor licence;</p> <p>(ii) Approved application for amendment of additional licensing condition (b) of liquor licence; and</p> <p>(iii) Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions (a) and (c) and the amendment of additional licensing condition (b) as follows:</p> <p style="padding-left: 40px;">The licensee shall be on duty on the premises between 3:00 a.m. and 11:00 a.m. except Sunday which is the weekly day off.</p>
