- The low-price basic funeral services to the needy (e.g. Comprehensive Social Security Assistance recipients) as recognized by the Social Welfare Department or other relevant agencies shall cover a basic, essential and complete service for the disposal of a dead body, including but not limited to the transport of the dead body from the hospital or mortuary to the Funeral Parlour, procurement of a coffin for the dead body, conduct of funeral ceremony at the Funeral Parlour, delivery of the dead body from the Funeral Parlour to the final disposal site and the cremation fee. According to the information, there are some licensed funeral parlours, such as Kowloon Funeral Parlour, International Funeral Parlour and Diamond Hill Funeral Parlour, which provide similar services. For details, please contact the relevant funeral parlours.
