1. 根據《公眾娛樂場所規例》(第 172A 章)的規定,牌照申請如涉及臨時構築物,發出的牌照有效期以一個月為限,但發牌當局可酌情決定續發牌照。為此,在確保相關處所、場地佈局及臨時構築物在牌照有效期內不會進行任何更改或加建工程的前提下,申請人可選擇利用公眾娛樂場所牌照申請書 (FEHB 104) 連同已簽署妥當的本承諾書,為其一段連續不多於三個月的同一臨時公眾娛樂節目,遞交申請一個不多於一個月牌照期的臨時公眾娛樂場所牌照及通知本署該申請人有意申請續發牌照(如獲批給上述牌照)。
