## 申請人須知 NOTICE TO APPLICANT

1. 《卡拉OK場所條例》(第17(1)(c)) 條規定，任何人以許可證所示明的卡拉OK場所名稱以外的名稱經營、料理、管理或以其他方式控制該場所，即屬犯罪。

Section 17(1)(c) of the Karaoke Establishments Ordinance (Cap. 573) provides that any person who operates, keeps, manages or otherwise has control of a karaoke establishment under any name other than the name of the karaoke establishment indicated in the permit commits an offence.

2. 持證人如欲把其卡拉OK場所名稱由許可證所示明的名稱更改為其他名稱，須向食物環境衛生署有關的分區辦事處秘書申請把新名稱簽註在許可證上。

Grantees have to apply to the District Secretary concerned of the Food and Environmental Hygiene Department for endorsement of a change of name in the permit if they intend to change the name of their karaoke establishment from the one indicated in the permit to other name.

3. 由收到卡拉OK場所更改名稱申請到原則上予以批准，一般需時14天。

The time for granting an approval-in-principle for change of name of a karaoke establishment will be 14 days from the date of receipt of such an application under normal circumstances.

4. 有關的分區辦事處秘書會安排約見持證人，以便把卡拉OK場所的新名稱簽註在許可證上，但持證人須遞交下列文件：

District Secretary concerned will arrange an appointment with the grantee for endorsing the new name of the karaoke establishment onto the permit provided that the grantee can submit the following documents :
