## **Notes on Application:**

1. Booking application should be made at least 1 month in advance.
2. The completed application form should be returned to our office by fax at 2735 8781 or by mail to the Health Education Exhibition and Resource Centre of the Food and Environmental Hygiene Department at Block S4, Kowloon Park, Tsim Sha Tsui, Kowloon.
3. FEHD does not undertake to accept all applications. Successful applicants will be issued with a confirmation notice.
4. Applying organizations should arrange to reserve a display area for the vehicle.
5. The entrance to the display area should be large enough (3.5m (H) x 7m (L) x 2.5m (W)) to accommodate the vehicle.
6. Applying organizations should be responsible for public safety and order during the programme.
7. A layout showing the locations of the display area, parking space of the vehicle and power connection points should be provided for our consideration.
8. Sufficient electricity (1 or 2 no. of 13-ampere single-phase power rectangular pin sockets) should be provided for the vehicle.
9. The minimum duration of stay is 2 hours.
10. Arrangement in case of Typhoon or Rainstorm Warning Signals issued 2 hours before the commencement of the programme:
  - ◆ When Typhoon Signal No. 3 or Red Rainstorm Warning or above is issued, the current programme will be cancelled and the event will be postponed;
  - ◆ When Typhoon Signal No.1 or Amber Rainstorm Warning is issued, the programme will continue.
