大富豪 BIG BOSS GENERATION 酒牌(附加酒吧批註)轉讓、修訂(更改店號)及續期申請 Application for Transfer, Amendment (Change of Shop Sign) and Renewal of Liquor Licence (with Bar Endorsement)	(i) 同意批准酒牌(附加酒吧批註)轉讓申請； (ii) 同意批准酒牌(附加酒吧批註)修訂(更改店號)申請；及 (iii) 同意續發為期 12 個月的酒牌(附加酒吧批註)，並施加下列附加持牌條件： (a) 處所須安裝具錄影功能的閉路電視設施，錄影範圍涵蓋處所的公用地方及男女廁入口，其解像度水平，須為即使環境昏暗，被拍攝人士的面容特徵仍能清晰可辨。安裝在男女廁入口的閉路電視不得侵犯在廁所內或使用廁所的人士的私隱。所有閉路電視錄像須保存至少 30 天，並在警方要求時提交警方查看。 (由於有關處所目前只持有暫准普通食肆牌照，按現行政策，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)
	(i) Approved application for transfer of the liquor licence (with bar endorsement); (ii) Approved application for amendment (change of shop sign) of the liquor licence (with bar endorsement); and (iii) Agreed to renew the liquor licence (with bar endorsement) for a 12-month period with the imposition of the following additional licensing condition:

(a) CCTV with recording facilities which cover the common area of the premises and entrance of both male and female toilets and of which the resolution is up to the extent that facial appearance of people captured by the CCTV can be clearly identified even in dim light, shall be installed. The positioning of the CCTV system at the entrance of the male and female toilets shall not infringe the privacy of any person within or using toilet. All CCTV records shall be kept for at least 30 days and be available for Police inspection as and when required.

(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)
