寶興企業有限公司 Able Wealth Enterprise Limited 酒牌轉讓、修訂(更改店號、業務性質及加簽酒吧批註)申請 Application for Transfer and Amendment (Change of Shop Sign and Business Nature, Addition of Bar Endorsement) of Liquor Licence	(i) 同意批准酒牌轉讓申請； (ii) 同意批准酒牌修訂(更改店號)申請； (iii) 同意批准酒牌修訂(更改業務性質)申請；及 (iv) 同意批准酒牌修訂(加簽酒吧批註)申請。 (i) Approved application for transfer of the liquor licence; (ii) Approved application for amendment (change of shop sign) of the liquor licence; (iii) Approved application for amendment (change of business nature) of the liquor licence; and (iv) Approved application for amendment (addition of bar endorsement) of the liquor licence.

THE STATION 酒牌(附加酒吧批註)續期申請 Application for Renewal of Liquor Licence (with Bar Endorsement)	同意續發為期 12 個月的酒牌(附加酒吧批註)，並修訂附加持牌條件(b)項和施加附加持牌條件(d)項及(e)項如下： (b) 持牌人須於每天午夜 12 時至上午 9 時留駐處所當值，每週一天例假除外； (d) 凌晨 2 時至上午 9 時，不得使用設於處所內而朝外的音樂設備或擴音設備或電視機；及 (e) 持牌人及處所職員須盡應盡的努力，確保售賣或供應的酒類飲品只供顧客在處所內飲用。 酒牌(附加酒吧批註)上原有的附加持牌條件(a)項及(c)項維持不變。 Agreed to renew the liquor licence (with bar endorsement) for a 12-month period with the amendment of existing additional licensing condition (b) and the imposition of the following additional licensing conditions (d) and (e) as follows: (b) The licensee shall be on duty on the premises between 12:00 midnight and 9:00 a.m. except one day which is the weekly day off ; (d) No music or other sound amplification device or TV is to be used within the premises facing outwards between 2:00 a.m. and 9:00 a.m. ; and (e) The licensee and the staff of the premises shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only. The existing additional licensing conditions (a) and (c) on the liquor licence (with bar endorsement) remained unchanged.
