Collection of Personal Data in Connection with Application for Temporary Suspension of Market Stall Business in Accordance with Personal Data (Privacy) Ordinance

Statement of Purpose

1. Purposes of Collection

The personal data provided by means of this Application form will be used by the Food and Environmental Hygiene Department (FEHD) for the following purposes-

- (a) Consideration of matters relating to applications for temporary suspension of market stall business;
- (b) dealing with matters relating to (a) above, including but not limited to compilation of records and preparation of tenancy agreement after approval of the application;
- (c) Facilitating communication among staff of FEHD, market management contractor and you; and
- (d) Disclosing the data to, if necessary, the Centre for Food Safety of FEHD in accordance with the Food Safety Ordinance. [Only confines to market stalls for selling foods]

The provision of personal data is voluntary. However, if you do not provide sufficient information, we may not be able to process your application for succession of the tenancy.

2. Class of Transferees

The personal data provided by means of this Application Form may be disclosed to other government departments/organisations in pursuance of the purposes mentioned in paragraph 1 above. The personal data may also be disclosed to other Government departments for law enforcement purposes.

3. Access to Personal Data

You have a right of access to and correction of the personal data as provided in accordance with Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of the personal data which you have provided by means of this Application form. A fee may be imposed for complying with a data access request.
