Question:

In Programme (2), it is mentioned under Matters Requiring Special Attention in 2025-26 that the Food and Environmental Hygiene Department will continue to take stringent enforcement actions against unlicensed food premises and food premises which pose immediate health hazards or with illegal extension of food business areas. In this connection, please advise this Committee of:

- 1) the number and nature of cases of irregularities detected, the types of premises involved, the districts concerned, as well as the number of prosecutions instituted in each of the past 5 years (2020-21 to 2024-25);
- 2) the number of repeated offenders among the persons prosecuted in the non-compliant cases in each of the past 5 years (2020-21 to 2024-25); and
- 3) whether the Department has, apart from stepping up enforcement actions, improved the licensing procedures as recommended by the Public Accounts Committee; if yes, the details; if no, the reason(s).

Reply:

- 1) The number of prosecutions instituted by the Food and Environmental Hygiene Department (FEHD) for operating unlicensed food business and the number of prosecutions for illegal extension of food business areas and obstruction in public places in the past 5 years are provided in Annexes I to II respectively. Besides instituting prosecution, FEHD has been more proactive in recent years in applying to the court for closure orders against food premises which persistently operate without a licence to curb contraventions. There was no case where a closure order against food premises posing immediate public health hazards was made during the period. FEHD does not keep a breakdown of the numbers of prosecutions instituted for illegal extension of food business areas/obstruction in public places by type of premises.
- 2) The numbers of cases of repeated contraventions (i.e. cases in which the persons prosecuted had previously committed the same offences) among the prosecutions

- instituted in the past 5 years (2020 to 2024) were 2 776, 3 849, 3 313, 3 589 and 3 016 respectively.
- 3) FEHD has, in response to the recommendations of the Public Accounts Committee, improved the licensing procedures by expediting the implementation of an electronic-referral system among the government departments, stepping up efforts in reminding applicants to comply with the licensing requirements within specified timeframes and facilitating applicants in checking their licence application status via an online system, etc.. FEHD has also taken measures to enhance the coordination and collaboration between Regional Licensing Offices and District Environmental Hygiene Offices, including updating guidelines and upgrading the information system to facilitate inter-office referral of cases of suspected unlicensed food premises. In addition, FEHD refers cases of unlicensed food premises to the Fire Services Department and the Buildings Department for follow-up. FEHD is considering the views of the trade on whether other measures should be adopted to tackle the act of unlicensed operation of food business before obtaining a provisional licence.
