Declaration made in Part II of the Application Form for the Subsidy Scheme:

- (a) the above licensed food business is in operation;
- (b) the information provided in this Application Form is true and correct to the best of my knowledge and belief, and I have not withheld any information required to be provided herein;
- (c) regardless of whether there are any other persons who are responsible for the operation of the above licensed food business, I am the person who is held responsible for this application;
- (d) the licensee is not subject to any bankruptcy or winding up procedure/proceedings/order at the time of the application and I shall immediately notify the Food and Environmental Hygiene Department (FEHD) if I am aware of any bankruptcy or winding up procedure/proceedings/order against the licensee after the date of application up to the date of grant of subsidy;
- (e) I understand that if there is any breach of Cap. 599F or the directions made thereunder, or licensing conditions of the food business licence relevant to this application, the Government will not rule out the possibility of giving consideration to rejecting the application and recovering from me any subsidy approved and all related expenses and/or requiring me to take appropriate measures;
- (f) I understand that if I have given any false information or made a false declaration in relation to this application, this application will be refused and any approval given will be revoked, and I may be held liable for any legal consequence arising. I also understand that the Government reserves the right to recover from me any approved subsidy granted and all related expenses incurred if any false information is given or false declaration is made by me in relation to this application;
- (g) the part of the licensed premises used as a nightclub has been closed during the period when the Directions are in effect (for applicant applying for the Additional Subsidy); and
- (h) I understand that the subsidy will be granted to me as an agent for the operator to operate the above licensed food business (for applicant who has ticked item 5(ii) in Part II of the Application Form) *[i.e. the catering business is operated by person other than the licensee himself]*.

I undertake that (for applicant who has ticked item 5(ii) in Part II of the Application Form), in consideration of FEHD's processing of this application, the subsidy received under the Scheme will be used for operating the above licensed food business and I shall return the subsidy to FEHD if the subsidy is not used for the said purpose.
