Rodent Problems in Residential Areas

In residential premises, improper treatment of household refuse provides ample food sources for rodents, while communal areas such as the refuse rooms, storerooms, the void under staircases, the flowerbeds and retaining walls are potential rodent harbourages. If there are no regular inspections and rodent-proofing measures, the premises and their surroundings are highly susceptible to rodent infestation.

Types and Characteristics of Rodents

Rodents are social animals living in family groups or colonies. They have good senses of smell, touch and hearing, and are good at swimming and climbing. A rodent can locate itself and direct movement by its strong memory. Their reproductive rate is very high: an adult female rodent can give birth to about 50 young rodents in a year. Common types of rodents include *Rattus norvegicus* (sewer rat), *Rattus rattus* (roof rat) and *Mus musculus* (house mouse).

Hazards caused by Rodents

1. Transmission of Diseases

The major problem caused by rodents is public health hazards. Rodents can directly or indirectly transmit to humans diseases such as plague, scrub typhus, urban typhus, hantavirus infection and leptospirosis. Rodents, living in dirty environment, are prone to carry pathogens. Ingestion of food and water contaminated by rodents may cause food poisoning and other infectious diseases.

2. Loss of Property

Rodents cause financial loss by gnawing building fittings and household furniture. They may gnaw and damage telephone wires and computer cables, and even bite electric wires or cables, causing fire due to short-circuiting.

3. Biting People

Rodents may bite people of low mobility, such as babies, the aged, the invalid, the disabled or people who are asleep.

Signs of Rodent Infestation

Apart from spotting live rodents around the premises, other signs of rodent infestation include rodent droppings, rat holes, runways, gnawing marks, footmarks and smears.

Rodent-Proofing Measures in Residential Premises

To prevent rodent infestation, management companies should maintain the premises in good environmental hygiene condition by:

- inspecting all flowerbeds and pavements regularly for rodent infestation;
- setting up a zone paved with concrete or small boulders as far as possible in immediate surrounding of building blocks;
- trimming surrounding bushland, long-grass fields and vegetation in flowerbeds regularly for easier detection of rodent infestation;
- · avoiding any accumulation of articles;
- clearing the household refuse from the premises at least once a day;
- tying up the refuse bags before disposal of in a refuse collection box with cover;
- cleansing the used dustbins daily;
- · clearing or flushing drains, gutters, sewers and septic tanks regularly
- clearing the refuse and articles in the communal areas as soon as possible.

Meanwhile, the following rodent-proofing measures should be adopted:

- Install gratings with apertures not more than 6 mm or plug barbed wire balls at the openings of pipes. Any defective gratings must be replaced as soon as possible.
- 2. Use cement or metal plates to properly seal all the openings left in the walls, floors or roofs after the installation of pipes, wires or split-type air conditioners.
- 3. Repair all defective pavements and walls with cement.
- Lower the threshold clearance of doors to not more than 6 mm and affix metal kicking plates of at least 30 cm high to the lower edges of doors and door frames.
- Install strong wire meshes with apertures not larger than 6 mm to screen exhaust fans and ventilation louvers.
- Install rat guards around the pipes on external walls.

- Place a refuse collection bin with a well-fitted cover on each floor to collect household refuse.
- Appoint a pest control company to disinfest the premises if there is rodent infestation. Do not try to catch rodents yourselves to avoid contracting rodentborne diseases.

Relevant Legislation

Under the amended section 47 of the Public Health and Municipal Services Ordinance (Chapter 132, Laws of Hong Kong), owner, occupier, owners' corporation or property management company of a premises has the responsibility to ensure that the premises is free from infestation of vermin.

If it appears to the Food and Environmental Hygiene Department (FEHD) that a particular premises is infested with vermin, the FEHD may serve a "Notice of Elimination of Vermin" to the owner or occupier of the premises, requiring them to take action to destroy and remove the vermin within a specified period. As for dealing with vermin infestation in the common parts of building, the FEHD may serve a "Notice of Elimination of Vermin" to the owners' corporation or property management company responsible for managing the common parts to ensure that the problem is addressed in a timely manner. Failure to comply with the notice is an offence. Upon conviction, the maximum penalty is a fine of \$25,000, plus a daily fine of \$450.

If the FEHD believes that immediate intervention is necessary due to the severity of the vermin infestation, it may take reasonable steps to destroy or remove the vermin from the premises, even without serving a "Notice of Elimination of Vermin", and may subsequently recover the costs incurred from the vermin elimination work.

Additionally, if the FEHD believes that a particular premises is infested with vermin, it may place any equipment used for conducting tests or assessing vermin proliferation (such as traps, bait containers, baits, etc.). Interference with such equipment is an offence. Upon conviction, the maximum penalty is a fine of \$5,000.
