Shun Shin Chee Kit Yin Koon Limited's <u>Exemption Application</u>

"Approval-in-principle for Exemption Application"

Based on the documents submitted by the applicant so far, the Private Columbaria Licensing Board (the Licensing Board) considers that the above exemption application is basically in compliance with the requirements for the exemption application, except for the requirements on the right to use the columbarium premises and the land-related requirements.

The Licensing Board has decided to give an approval-in-principle for the above exemption application, the "approval-in-principle for exemption application" is valid for one year (i.e. from 25 November 2022 to 24 November 2023). If the applicant has not complied with the above requirements and notified the Licensing Board (c/o PCAO) in writing of its compliance with those requirements within the one-year validity period of this "approval-in-principle for exemption application", the Licensing Board will re-examine this exemption application.
