



Statement of Purpose

(1) **Purposes of Collection**

(a) handling applications for an Exemption under the PCO and related matters. These may include posting

of public notices of the application in such manner as determined by the Private Columbaria

departments and yourself concerning the operation of your columbarium business.

(3) Access to Personal Data

Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of

access includes the right to obtain a copy of your personal data which you have provided by means of this

form. A fee may be imposed for complying with a data access request.
