List of private columbaria which have not submitted the required documents/information for one or more domain(s) of application requirements for Temporary Suspension of Liability (TSOL) application by the deadline of 31 December 2019 and are subject to the cessation of vetting of TSOL applications by the Private Columbaria Licensing Board (PCLB)

It is stipulated under the Private Columbaria Ordinance (the Ordinance) that applications for specified instruments in respect of pre-cut-off columbaria ¹ must be submitted before the expiry of 9 months beginning on the enhancement date of the Ordinance (i.e. on or before 29 March 2018). In October 2017, the PCLB promulgated the "Application Guide for Private Columbarium Licence or Other Specified Instruments" (the Application Guide) setting out in detail to the potential applicants the application requirements and the documents/information required to be submitted for each type of specified instrument (i.e. licence, exemption and TSOL) application.

As announced on 30 August 2019, the PCLB had set 31 December 2019 as the deadline for submission of documents/information in respect of TSOL applications. In fact, two years have passed since the PCLB promulgated the Application Guide in October 2017 up to the deadline of 31 December 2019.

After the deadline of 31 December 2019, the PCLB has carefully examined the status of applicants' submission of documents/information for their TSOL applications. With regard to 15 private columbaria that have not submitted the documents/information² required for one or more domains of the application requirements for TSOL application by the deadline, the PCLB has decided to cease the vetting of their TSOL applications. The PCLB will decide when to hold open meetings to

determine these TSOL applications having regard to the circumstances of each individual case.

For the list of private columbaria subject to cessation of vetting of TSOL applications by the PCLB, please refer to **Annex**.

When the PCLB determines the aforementioned TSOL applications, the PCLB will refuse these applications if the applications have not complied with all the application requirements under the Ordinance and the requirements stipulated by the PCLB for TSOL application. If the licence/exemption applications submitted together with the TSOL applications do not comply with all the application requirements under the Ordinance and the requirements stipulated by the PCLB for licence/exemption application, the PCLB will refuse the whole set of applications.
