

Commencement of ash disposal notice

Section 8 of Schedule 5 to Private Columbaria Ordinance (the "Ordinance")

Name of the private columbarium : SHATIN PO FOOK HILL MIU KING TONG

Address of the private columbarium :

PO FOOK HILL, PAI TAU STREET, SHA TIN, N.T. (SHA TIN TOWN LOT NO.311)

This organization is the Operator of the above private columbarium.

Intention with respect to the manner of ash disposal

This organization is going to carry out the "Prescribed Ash Disposal procedures" in respect of the above private columbarium, and will handle the ashes interred in the said columbarium in the following manner :

- (1) To handle the ashes interred in the said columbarium in the specified manner within the meaning of section 7(3) of Schedule 5 to the Ordinance ;
- (2) To arrange for the return of ashes on-site, allowing for an "On-site Claim Period" of 8 months in the period specified below :
The date on which the "On-site Claim Period" begins : 25-JAN-2020 .
The date on which the "On-site Claim Period" ends : 25-SEP-2020 .
- (3) To handle the claims for the return of ashes and any related item in accordance with sections 9 and 10 of Schedule 5 to the Ordinance ;
- (4) To arrange for the removal of the ashes in respect of which no claims have been received and are not returned to an eligible claimant after the expiry of the above "On-site Claim Period" from the above columbarium, and arrange for the reinterment of those ashes (i) in a columbarium in respect of which a licence is in force or a columbarium listed out in section 4 of the Ordinance; and (ii) on terms no less favourable than the terms governing interment of the ashes in the original columbarium by 31-DEC-2020 ;
- (5) The name of the columbarium in Which the ashes are to be reinterred is SHATIN PO FOOK HILL (EXCLUDING MIU KING TONG) 妙門堂, 妙日堂, 妙會堂
- (6) The address of the columbarium in Which the ashes are to be reinterred is PO FOOK HILL, PAI TAU STREET. SHA TIN, N.T. (SHA TIN TOWN LOT NO.311)
- (7) To take the steps that the Director of Food and Environmental Hygiene (the "Director") considers necessary to facilitate the return of ashes to their eligible claimants, the delivery of ashes to the Director or the reinterment of ashes under section 13 of Schedule 5 to the Ordinance ;
- (8) To comply with the requirement under section 12 of Schedule 5 to the Ordinance for the delivery of a record of the ash disposal procedures to the Director.

The carrying out of the said "Prescribed Ash Disposal Procedures" does not affect any person's right to compensation under an agreement for the sale of an interment right in respect of the above private columbarium.
