Dragonfly Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; (b) No liquor shall be sold or supplied for consumption on the premises between 1:00 a.m. and 9:00 a.m.; and

	 (c) The licensee shall ensure that liquor sold or supplied shall be consumed on the premises only. (The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)
