Baby B Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: (a) The licensee shall be on duty on the premises from 10:00 p.m. to the end of business hours except Sunday which is the weekly day off; and (b) No sound amplification device shall be switched on and no music shall be played on the premises between 11:00 p.m. and 9:00 a.m. the following day.

ICHU Application for Transfer and Renewal of Liquor Licence	(i) Approved application for transfer of liquor licence; and (ii) Agreed to issue a 12-month liquor licence with the retention of existing additional licensing condition and the imposition of the following additional licensing condition: All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day.
