Liquor Licensing Board's Decision on Open Hearing Cases

<b>NISSA LA BELLA</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  (a) All doors and windows of the premises shall be kept closed between 8:00 p.m. and 9:00 a.m. the following day;  (b) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 9:00 a.m. the following day;  (c) No liquor shall be consumed on the premises between 12:00 midnight and 9:00 a.m.; and  (d) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only.  ( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Liquor Licensing Board will first issue a liquor licence with an expiry date being the same as that of the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Liquor Licensing Board will issue a liquor licence for the remaining approved period. )

<p><b>Bocadito</b> Application for Amendment of Additional Licensing Condition and Renewal of Liquor Licence</p>	<p>(i) Refused application for amendment of additional licensing condition of liquor licence; and</p> <p>(ii) Agreed to issue a 12-month liquor licence with the retention of the existing additional licensing condition (b) and the amendment of the existing additional licensing condition (a) as follows:</p> <p>(a) All doors and windows of the premises shall be kept closed between 9:00 p.m. and 9:00 a.m. the following day.</p>
