<b>White Beard Fish N Chips</b> 酒牌續期申請	同意續發為期 12 個月的酒牌，並維持酒牌上原有的附加持牌條件。
<b>新高麗苑韓國餐廳</b> <b>New Korean BBQ Restaurant</b> 新酒牌申請	同意簽發為期 12 個月的酒牌。  (由於有關處所目前只持有暫准普通食肆牌照，按現行政策，酒牌局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)
<b>The Old Man and the Sea</b> Application for Transfer of Liquor Licence	Approved application for transfer of liquor licence with the retention of existing additional licensing conditions.
<b>DISTRICT EIGHT</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing condition:  All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day.

	<p>( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Liquor Licensing Board will first issue a liquor licence with an expiry date being the same as that of the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Liquor Licensing Board will issue a liquor licence for the remaining approved period. )</p>
<p><b>SHADY ACRES</b> Application for Transfer, Amendment of Additional Licensing Condition and Renewal of Liquor Licence</p>	<p>(i) Approved application for transfer of liquor licence;</p> <p>(ii) Refused application for amendment of additional licensing condition (a); and</p> <p>(iii) Agreed to issue a 9-month liquor licence with the retention of existing additional licensing conditions (b) and (c) and the amendment of additional licensing condition (a) as follows:</p> <p style="padding-left: 40px;">(a) All doors and windows of the premises shall be kept closed between 9:00 p.m. and 9:00 a.m. the following day;</p> <p style="padding-left: 40px;">and the imposition of the following additional licensing condition:</p> <p style="padding-left: 40px;">(d) The licensee shall ensure that liquor sold or supplied is to be consumed on the premises only.</p>
