	 (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day;
	(b) No liquor shall be sold or supplied for consumption on the premises between 1:00 a.m. and 9:00 a.m.;
	 (c) No consumption of liquor shall be allowed on the premises between 2:00 a.m. and 9:00 a.m.; and
	(d) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only.
	(Since the premises are currently issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), in accordance with the existing policy, the Liquor Licensing Board will first issue a liquor licence with an expiry date being the same as that of that of the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Liquor Licensing Board will issue a liquor licence for the remaining approved period.)
