正斗火焗海鮮館 考慮撤銷酒牌	撤銷酒牌。
<b>Artisan Brewer</b> 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件： (a)晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；及 (b)凌晨 2 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用。  (由於有關處所目前只持有暫准普通食肆牌照，按現行政策，酒牌局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)
