**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
<b>Cutty Sark</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  i) All doors and windows of the premises shall be kept closed after 6:00 p.m.; and  ii) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 7:00 a.m. the next morning.  ( The premises are currently applying for a Light Refreshment Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )
<b>The P&amp;L Club</b> 新會社酒牌申請	同意簽發為期 12 個月的會社酒牌。  (由於處所尚未獲簽發會社合格證明書，按現行政策，待處所獲發會社合格證明書後，才安排簽發會社酒牌，屆時並會附加有關人數限額的持牌條件。)

<p><b>Finds Scafe Bar</b>  Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence.</p> <p>( The premises are currently applying for a General Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
