Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
The Evisu Bar Application for New Issue of Liquor Licence	Agreed to issue a 6-month liquor licence with the imposition of the following additional licensing conditions: i) All doors and windows of the premises shall be kept closed after 11:00 p.m.; ii) No patrons shall be allowed on the open area outside the premises after 11:00 p.m.; and iii) Not more than 64 persons, including staff, shall be permitted on the premises at any one time. (Since the premises are currently issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)

<p>太平洋酒吧 Bar Pacific 新酒牌申請</p>	<p>同意簽發為期 6 個月的酒牌，並附加下列持牌條件：</p> <p>凌晨 2 時後，不得售賣或供應酒類飲品供顧客在處所內飲用。</p> <p>(由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘有關處所只獲發暫准小食食肆牌照，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
