Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
Dragon-i Application for Renewal of Liquor Licence	Agreed to issue a 6-month liquor licence with the retention of existing additional licensing conditions.
Vargas Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: i) All doors and windows of the premises shall be kept closed after 6:00 p.m.; ii) No liquor shall be sold or supplied for consumption on the premises after 1:00 a.m.; and iii) No liquor shall be sold or supplied for consumption and no person shall consume liquor at the cockloft of the premises at any time. (The premises are currently applying for a Light Refreshment Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)
