Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
Rick's on Elgin Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: i) All doors and windows of the premises shall be kept closed after 11:00 p.m.; ii) No liquor shall be sold or supplied for consumption on the premises after 1:00 a.m. from Sundays to Thursdays and 2:00 a.m. on Fridays and Saturdays; and iii) Not more than 49 persons, including staff, shall be permitted on the premises at any one time. (Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)
