Liquor Licensing Board's Decision on Open Hearing Cases

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
<b>Liquor Store</b> 考慮撤銷酒牌	撤銷酒牌。
<b>Caramba</b> Application for Renewal of Liquor Licence	Agreed to issue a 9-month liquor licence with the retention of existing additional licensing conditions.
<b>GURU</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  i) All doors and windows of the premises shall be kept closed after 6:00 p.m.;  ii) No liquor shall be sold or supplied for consumption on the premises after 12:00 midnight; and  iii) No more than 50 persons, including staff, shall be permitted on the premises at any one time.

<p><b>Makumba</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions and the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>i) No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m.; and</li> <li>ii) No live music or other sound amplification or musical instrument is to be played or performed on the premises after 2:00 a.m.</li> </ul>
<p><b>Dragon-i</b> Application for Renewal of Liquor Licence</p>	<p>Pending assessment/review of the capacity limit of the premises by the Buildings Department, the Board agreed to issue a 3-month liquor licence with the retention of existing additional licensing conditions and the imposition of the following additional licensing condition:</p> <p>A recording CCTV system shall be installed and operational inside the premises covering and recording the entrance to both the male and female toilets and the vicinity thereof. The positioning of such CCTV system should not be within the toilet or impinge upon the privacy of any person within or using the toilet. The recorded image to be maintained by the licensee for a minimum period of one calendar month and to be made available to Police as required or requested by Police.</p>

<p><b>品味廊</b> <b>Stylish Lounge</b> 酒牌轉讓及續期申請</p>	<p>(a) 同意批准酒牌轉讓申請；及</p> <p>(b) 同意續發為期 3 個月的酒牌，除維持酒牌上原有的附加持牌條件外，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>i) 持牌人須於每天晚上 10 時 30 分至翌晨 7 時留駐處所當值，每週星期日例假除外；及</li> <li>ii) 不得容許 18 歲以下人士進入處所。</li> </ul>
