Zest Application for Amendment (Change of Shop Sign)	Approved application for amendment (change of shop sign) with the imposition of the following additional licensing conditions: <ul style="list-style-type: none">i) All doors and windows of the premises shall be kept closed after 11:00 p.m.; andii) No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m.

<p>Escape on Fenwick Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 9-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> i) No more than 287 persons, including staff, shall be permitted on the premises at any one time; and ii) The licensee shall be on duty on the premises from 9:00 p.m. to 3:00 a.m. next morning, except Sunday which is the weekly day-off. <p>(The premises are currently applying for a Light Refreshment Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>

(b) Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing condition: <ul style="list-style-type: none"> Liquor shall only be sold or supplied for consumption on the outside seating accommodation of the premises from 11:00 a.m. to 11:00 p.m.
