<b>紐約卡拉 O · K · 夜總會 New York Karaoke Night Club</b> 新酒牌申請	同意簽發為期 12 個月的酒牌。
<b>Ebenezer's Kebab &amp; Pizzeria</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  i) No liquor shall be sold or supplied for consumption on the premises between 5:00 a.m. and 10:00 a.m.; and  ii) The licensee shall ensure that no person consumes liquor on the premises between 5:00 a.m. and 10:00 a.m.

<p><b>Bloom</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing condition:</p> <p style="text-align: center;">No more than 151 persons for 5/F and 120 persons for 6/F, including staff, shall be permitted on the premises at any one time.</p> <p>( The premises are currently applying for a General Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )</p>
<p><b>Shake Shake</b> 新酒牌申請</p>	<p>同意簽發為期 12 個月的酒牌，並附加下列持牌條件：</p> <p style="text-align: center;">在任何同一時間內，處所的總人數連同職員在內不得超過 295 人。</p> <p>( 酒牌上的跳舞批註須待消防處處長證實處所已符合有關的消防規定後，方能生效。由於有關處所目前只持有暫准小食食肆牌照，按現行政策，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。 )</p>
<p><b>Dragon-i</b> Application for Renewal of Liquor Licence</p>	<p>Pending assessment/review of the capacity limit of the premises after 11:00 p.m. by the Buildings Department, the Board agreed to issue a 3-month liquor licence with the retention of existing additional licensing conditions.</p>
