288 The Melting Pot Application for Transfer, Amendment (Shop Sign and Additional Licensing Condition) and Renewal of Liquor Licence	(a) Approved application for amendment (Change of Shop Sign) and amendment of an existing additional licensing condition specifying the liquor selling hours as follows: <p style="text-align: center;">No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m.</p> (b) Approved application for transfer of liquor licence subject to all existing and amended additional licensing conditions; and (c) Agreed to issue a 9-month liquor licence with the retention of all existing and amended additional licensing conditions and the imposition of the following additional licensing condition: <p style="text-align: center;">No live music or musical instrument is to be played or performed on the premises after 12:00 midnight.</p>
