<b>Ebenezers</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: <ul style="list-style-type: none"><li>i) All doors and windows of the premises shall be kept closed after 9:00 p.m.; and</li><li>ii) No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m.</li></ul> ( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )
