**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
<b>Bar George</b> Consideration of Revocation of Liquor Licence	Revoked the liquor licence.
<b>The Tavern</b> Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:  i) All doors and windows of the premises shall be kept closed after 11:00 p.m.; and  ii) No liquor shall be sold or supplied for consumption on the premises after 2:00 a.m.  ( Since the premises are currently issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )

<p><b>江記海鮮菜館</b> <b>Kwong Kee Seafood Restaurant</b> 新酒牌申請</p>	<p>同意簽發為期 6 個月的酒牌。  (由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准普通食肆牌照，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
<p><b>Noble</b> 新酒牌申請</p>	<p>同意簽發為期 6 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>(i) 按屋宇署的評估限制處所可容納的人數上限；</li> <li>(ii) 持牌人須於每天下午 6 時至翌晨 3 時留駐處所當值，每週星期日例假除外；及</li> <li>(iii) 不得容許 18 歲以下人士進入處所。</li> </ul>
