小白屋西餐 • 甜品 <b>Cherry Garden</b> 考慮撤銷酒牌	撤銷酒牌。
乾杯串燒居酒屋 <b>Ganbei Yakitori Restaurant</b> 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件：  i) 晚上 10 時至翌日下午 5 時，處所的所有門窗必須保持關閉；  ii) 午夜 12 時至下午 5 時，不得售賣或供應酒類飲品供顧客在處所內飲用；及  iii) 晚上 11 時至翌日下午 5 時，任何人不得進出處所的露天地方以及在該處逗留。  (由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准小食食肆牌照，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

<p><b>Piadina</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>i) All doors and windows of the premises shall be kept closed between 10:00 p.m. and 11:00 a.m.;</li> <li>ii) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 11:00 a.m.;</li> <li>iii) No person shall be allowed for consumption of liquor on the premises between 11:00 p.m. and 11:00 a.m.;</li> <li>iv) No music or other sound amplification device or TV is to be played or used between 11:00 p.m. and 11:00 a.m; and</li> <li>v) The licensee shall with due diligence ensure that the liquor sold or supplied is to be consumed on the premises only.</li> </ul> <p>( The premises are currently applying for a Light Refreshment Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )</p>
<p><b>The Jockey</b> Application for Transfer of Liquor Licence</p>	<p>Approved application for transfer of liquor licence with the retention of existing additional licensing condition and the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>i) All doors and windows of the premises shall be kept closed after 11:00 p.m.; and</li> <li>ii) No person shall be allowed to stay at the Outside Seating Accommodation of the premises after 11:00 p.m.</li> </ul>

<p><b>DHARMA DEN</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 6-month liquor licence with the amendment of existing additional licensing conditions as follows:</p> <ul style="list-style-type: none"> <li>i) All doors and windows of the premises shall be kept closed between 6:00 p.m. and 5:00 p.m. the following day;</li> <li>ii) No person shall be allowed on the open area outside the premises between 11:00 p.m. and 5:00 p.m. the following day;</li> <li>iii) No speaker or other sound amplification of the premises is to be used between 11:00 p.m. and 5:00 p.m. the following day either outside the premises or within the structure of the premises facing outwards; and</li> </ul> <p>The other existing additional licensing condition on the liquor licence remains unchanged.</p>
<p><b>X Pub</b> 酒牌修訂(更改附加持牌條件)及續期申請</p>	<p>(a) 拒絕批准修訂(更改附加持牌條件)申請；及 (b) 同意續發為期 6 個月的酒牌，並維持酒牌上原有的附加持牌條件。</p>
<p><b>Y-5</b> 考慮撤銷會社酒牌</p>	<p>撤銷會社酒牌。</p>
<p><b>Foxy</b> 考慮撤銷酒牌</p>	<p>撤銷酒牌。</p>
