Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
Interlude 新會社酒牌申請	同意簽發為期 12 個月的會社酒牌，並附加下列持牌條件： 處所只可在下午 6 時至翌晨 1 時售賣或供應酒類飲品供顧客於處所內飲用。 (由於處所尚未獲簽發會社合格證明書，按現行政策，待處所獲發會社合格證明書後，才安排簽發會社酒牌，屆時並會在酒牌上附加持牌條件，按會社合格證明書的規定限制處所可容納的人數上限。)
Vivo 酒牌修訂(更改附加持牌條件)及續期申請	(a) 拒絕批准酒牌修訂(更改附加持牌條件)申請； (b) 同意續發為期 12 個月的酒牌，並修訂原有的附加持牌條件如下： i) 下午 6 時至上午 11 時，處中的所有門窗必須保持關閉； ii) 晚上 11 時至上午 11 時，不得售賣或供應酒類飲品供顧客在處所內飲用；及 酒牌上其餘原有的附加持牌條件則維持不變。

<p>Wagyu Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows:</p> <ul style="list-style-type: none"> i) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 7:00 a.m.; ii) The licensee shall be on duty on the premises from 7:00 p.m. to 3:00 a.m. next morning except Wednesday which is the weekly day-off ; <p>and the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> i) No liquor shall be sold or supplied for consumption on the premises between 2:00 a.m. and 7:00 a.m.; ii) Not more than 86 persons, including staff, shall be permitted on the premises at any one time; iii) The licensee shall with due diligence ensure that the liquor sold or supplied is to be consumed on the premises only; and <p>The other existing additional licensing condition on the liquor licence remains unchanged.</p>
<p>Amour Limited 新會社酒牌申請</p>	<p>同意簽發為期 12 個月的會社酒牌，並附加下列持牌條件：</p> <p>在任何同一時間內，處所的總人數連同職員在內不得超過 29 人。</p>
<p>金象泰式菜館 The Jolly Elephant Thailand Restaurant 新酒牌申請</p>	<p>同意簽發為期 9 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> i) 晚上 11 時至翌日上午 11 時，不得售賣或供應酒類飲品供顧客在處所內飲用；及 ii) 持牌人須盡應盡的努力，確保售賣或供應的酒類飲品只供顧客於處所內飲用。
