	and the imposition of the following additional licensing conditions:
	i) No liquor shall be sold or supplied for consumption on the premises between 2:00 a.m. and 7:00 a.m.;
	ii) Not more than 86 persons, including staff, shall be permitted on the premises at any one time;
	iii) The licensee shall with due diligence ensure that the liquor sold or supplied is to be consumed on the premises only; and
	The other existing additional licensing condition on the liquor licence remains unchanged.
