<b>Green Mouse</b> 酒牌修訂(附加酒吧批註、更改店號、業務性質和附加持牌條件)及轉讓申請	(a) 拒絕批准酒牌修訂(更改附加持牌條件)申請；及 (b) 同意批准酒牌修訂(附加酒吧批註、更改店號及業務性質)申請； (c) 同意批准酒牌轉讓申請，並修訂原有的附加持牌條件及附加新持牌條件如下： i) 下午 6 時至翌日下午 4 時，處所的所有門窗必須保持關閉； <i>(修訂)</i> ii) 晚上 11 時至翌日下午 4 時，不得售賣或供應酒類飲品供顧客在處所內飲用； <i>(修訂)</i> 及 iii) 午夜 12 時至下午 4 時，不得容許任何人在處所飲用酒類飲品。 <i>(新增)</i>

<p><b>MyPlace</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>i) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 3:00 p.m. the following day; and</li> <li>ii) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 3:00 p.m.</li> </ul> <p>( The premises are currently applying for a Light Refreshment Restaurant Licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )</p>

<p><b>Stan Cafe</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing condition:</p> <p style="padding-left: 40px;">The licensee shall with due diligence ensure that the liquor sold or supplied is to be consumed on the premises only.</p> <p>( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )</p>
<p><b>Staunton Street Café</b> Application for Transfer of Liquor Licence</p>	<p>Approved application for transfer of liquor licence with the amendment of existing additional licensing conditions as follows:</p> <ul style="list-style-type: none"> <li>i) No liquor shall be sold or supplied for consumption on the premises between 2:00 a.m. and 8:00 a.m.;</li> <li>ii) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 8:00 a.m.;</li> <li>iii) Liquor can only be sold, supplied or consumed in the Outside Seating Accommodation between 11:00 a.m. and 11:00 p.m.;</li> </ul> <p>and the imposition of the following additional licensing condition:</p> <ul style="list-style-type: none"> <li>i) The licensee shall with due diligence ensure that except the Outside Seating Accommodation between 11:00 a.m. and 11:00 p.m., the liquor sold or supplied is to be consumed on the premises only; and</li> </ul> <p>The other existing additional licensing conditions on the liquor licence remain unchanged.</p>
