**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
豆苗居 <b>Grassroots Pantry</b> 新酒牌申請	同意簽發為期 6 個月的酒牌，並附加下列持牌條件：  i) 下午 6 時至翌日中午 12 時，處所的所有門窗必須保持關閉；及  ii) 晚上 11 時至翌日中午 12 時，不得在處所內飲用酒類飲品。  (由於有關處所目前未獲簽發有效的食肆牌照，按現行政策，本局會待處所獲發有效食肆牌照後，才安排簽發新的酒牌。倘若有關處所只獲發暫准普通食肆牌照，本局會先行簽發一個與暫准普通食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

<p><b>H.E.A.T.</b>          酒牌修訂(更改附加持牌條件)及續期申請</p>	<p>同意續發為期 12 個月的酒牌，並修訂原有的附加持牌條件如下：</p> <ul style="list-style-type: none"> <li>i) 凌晨 2 時至中午 12 時，不得售賣或供應酒類飲品供顧客在處所內飲用；</li> <li>ii) 凌晨 2 時至中午 12 時，不得在處所內飲用酒類飲品；</li> <li>iii) 持牌人須於星期五、星期六，以及公眾假期前一天的晚上 9 時至翌晨 2 時留駐處所當值；</li> <li>iv) 午夜 12 時至中午 12 時，處所內不得演奏或播放音樂，也不得使用其他擴音設備或演奏樂器；及</li> </ul> <p>酒牌上其餘原有的附加持牌條件則維持不變。</p>
<p><b>PAISANO'S</b>          Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>i) No person shall be allowed for consumption of liquor on the premises between 2:00 a.m. and 8:00 a.m.;</li> <li>ii) No person shall be allowed on the balcony outside the premises between 11:00 p.m. and 8:00 a.m. the following day;</li> <li>iii) No music or other sound amplification shall be played on the premises between 11:00 p.m. and 8:00 a.m. the following day; and</li> <li>iv) The doors and windows separating the premises and the balcony shall be kept closed between 11:00 p.m. and 8:00 a.m. the following day.</li> </ul> <p>( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )</p>

<p>金福園潮州小廚打冷 酒牌轉讓及續期申請</p>	<p>(a) 同意批准酒牌轉讓申請；及</p> <p>(b) 同意續發為期 6 個月的酒牌，並附加下列持牌條件：</p> <p>晚上 11 時至翌日上午 10 時，不得售賣或供應酒類飲品供顧客在處所內飲用。</p>
