| <b>Jack's Pizzeria</b><br>Application for New Issue of<br>Liquor Licence | Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:<br><br>(a) All doors and windows of the premises shall be kept closed between 10:00 p.m. and 9:00 a.m. the following day;<br><br>(b) No liquor shall be sold or supplied for consumption and no liquor shall be consumed on the premises after 11:00 p.m.; and<br><br>(c) All liquor sold shall be consumed at the indoor part of the premises only and no liquor shall be consumed at the outdoor part of the premises outside the main door.<br><br>( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. ) |
