<b>嚙粵酒家</b> <b>Canton Kitchen</b> 酒牌轉讓及修訂(更改店號及業務性質、加簽酒吧批註及擴大售酒範圍)申請	同意批准酒牌轉讓及修訂(更改店號及業務性質、加簽酒吧批註及擴大售酒範圍)申請，並附加下列持牌條件：  (a) 下午 6 時至翌日上午 9 時，處所的所有門窗必須保持關閉；及  (b) 在任何同一時間內，大廈入口右方的小部分的總人數連同職員在內不得超過 30 人，而大廈入口左方的主要部分的總人數連同職員在內不得超過 232 人。  (由於有關處所目前只持有暫准小食食肆牌照，按現行政策，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)

<p><b>JAA Kitchen</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows:</p> <ul style="list-style-type: none"> <li>(a) All doors of the premises shall be kept closed between 6:00 p.m. and 9:00 a.m. the following day and the 2 windows facing Man Hing Lane shall be kept locked between 6:00 p.m. and 9:00 a.m. the following day;</li> <li>(b) No liquor shall be sold or supplied for consumption on the premises between 1:00 a.m. and 9:00 a.m.;</li> <li>(c) No person shall be allowed for consumption of liquor on the premises between 2:00 a.m. and 9:00 a.m.;</li> <li>(d) No music or other sound amplification shall be played on the premises between 11:00 p.m. and 9:00 a.m. the following day; and</li> </ul> <p>The other existing additional licensing condition on the liquor licence remains unchanged.</p>

<p><b>Tuk-Tuk Thai Restaurant</b> Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the amendment of existing additional licensing conditions as follows:</p> <ul style="list-style-type: none"> <li>(a) The sliding doors of the premises shall be kept closed between 6:00 p.m. and 9:00 a.m. the following day; and</li> <li>(b) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 9:00 a.m. the following day.</li> </ul>

<p>太平洋酒吧 <b>Bar Pacific</b> 新酒牌申請</p>	<p>同意簽發為期 9 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>(a) 晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；</li> <li>(b) 凌晨 1 時至上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用；</li> <li>(c) 凌晨 2 時至上午 9 時，持牌人須確保處所內無人飲用酒類飲品；</li> <li>(d) 午夜 12 時至上午 9 時，不得在處所內使用卡拉 OK 設備或其他擴音設備播放音樂或輸出聲響；及</li> <li>(e) 持牌人須於每天晚上 8 時至翌晨 2 時留駐處所當值，每週一天例假除外。</li> </ul> <p>(由於有關處所目前只持有暫准小食食肆牌照，按現行政策，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)</p>
