Fluid Application for Amendment of Additional Licensing Condition and Renewal of Liquor Licence	(i) Agreed to issue a 12-month liquor licence; (ii) Approved application for amendment of an additional licensing condition to extend the liquor selling and supply hours inside the folding doors to 1:00 a.m. and such amended additional licensing condition should read as follows: No liquor shall be sold or supplied for consumption on the premises inside the folding doors between 1:00 a.m. and 9:00 a.m. and no liquor shall be sold or supplied for consumption on the premises outside the folding doors between 11:00 p.m. and 9:00 a.m. the following day; and The other existing additional licensing condition on the liquor licence remains unchanged.
Origin Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.
