Liquor Licence

Agreed to issue a 9-month liquor licence with the imposition of the following additional licensing conditions:

- (a) All doors and windows of the premises shall be kept closed between 6:00 p.m. and 9:00 a.m. the following day;
- (b) No liquor shall be sold or supplied for consumption on the premises between 10:00 p.m. and 9:00 a.m. the following day;
- (c) No person shall be allowed to stay on the premises between 11:00 p.m. and 9:00 a.m. the following day;
- (d) No music or other sound amplification device or TV shall be played or used on the premises between 11:00 p.m. and 9:00 a.m. the following day; and
- (e) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only.

(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)
