<p>Nosh Tai Ping Shan Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) All doors and windows of the premises shall be kept closed between 6:00 p.m. and 9:00 a.m. the following day; (b) No liquor shall be sold or supplied for consumption on the premises between 9:00 p.m. and 9:00 a.m. the following day; (c) No liquor shall be consumed on the premises between 10:00 p.m. and 9:00 a.m. the following day; (d) No music or other sound amplification device or TV shall be played or used on the premises between 10:00 p.m. and 9:00 a.m. the following day; (e) No patron shall be allowed in the open yard of the premises between 10:00 p.m. and 9:00 a.m. the following day; and (f) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only. <p>(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>

Boujis Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing condition.
Wagyu Application for Amendment of Additional Licensing Condition and Renewal of Liquor Licence	(i) Refused application for amendment of additional licensing condition; and (ii) Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.
