Stockton Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: <ul style="list-style-type: none">(a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day;(b) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.; and(c) No music or other sound amplification device or TV is to be used either outside the premises or within the premises facing outwards. <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>

<p>La Terrasse Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence.</p>

<p>Plat du Jour Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <p>(a) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 9:00 a.m. the following day; and</p> <p>(b) The licensee shall with due diligence ensure that liquor sold or supplied is to be consumed on the premises only.</p> <p>(Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>

<p>M1 酒牌續期申請</p>	<p>同意續發為期 12 個月的酒牌，並維持酒牌上原有的附加持牌條件。</p>

<p>VIDI / VICI 酒牌續期申請</p>	<p>同意續發為期 9 個月的酒牌，並附加下列持牌條件：</p> <ul style="list-style-type: none"> (a) 持牌人須於每天晚上 8 時至翌晨 2 時留駐處所當值，每週星期日例假除外； (b) 晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；及 (c) 晚上 11 時至翌日上午 9 時，不得在處所內現場演奏音樂。
<p>Pub Ceason 酒牌續期申請</p>	<p>同意續發為期 3 個月的酒牌，並維持酒牌上原有的附加持牌條件。</p>
