Alchemy Application for New Issue of Liquor Licence	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none">(a) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 9:00 a.m. the following day;(b) No consumption of liquor shall be allowed on the premises between 12:00 midnight and 9:00 a.m.;(c) No loudspeaker or sound amplification device or TV shall be switched on and no music shall be played on the premises between 11:00 p.m. and 9:00 a.m. the following day;(d) All doors and windows of the premises shall be kept closed between 6:00 p.m. and 9:00 a.m. the following day;(e) The licensee shall ensure that liquor sold or supplied is to be consumed on the premises only; and(f) Not more than 30 persons on LG/F and 81 persons on G/F, including staff, shall be permitted on the premises at any one time. <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
