Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
Corner Kitchen Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the amendment of an existing additional licensing condition as follows: No sound amplification device or TV shall be switched on and no music shall be played on the premises between 11:00 p.m. and 9:00 a.m. the following day; and The other existing additional licensing conditions on the liquor licence remain unchanged.
Corner Kitchen Bakery & Cafe Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: (a) All doors and windows of the premises shall be kept closed between 6:00 p.m. and 8:00 a.m. the following day; (b) No liquor shall be sold or supplied for consumption on the premises between 11:00 p.m. and 8:00 a.m. the following day; and (c) No sound amplification device or TV shall be switched on and no music shall be played on the premises between 11:00 p.m. and 8:00 a.m. the following day.

同意簽發為期 12 個月的酒牌，並附加下列持牌條件：

- (a) 晚上 11 時至翌日上午 9 時，不得售賣或供應酒類飲品供顧客在處所內飲用；
- (b) 午夜 12 時至上午 9 時，不得在處所飲用酒類飲品；
- (c) 晚上 11 時至翌日上午 9 時，處所內不得將擴音設備開著，也不得演奏或播放音樂；
- (d) 下午 6 時至翌日上午 9 時，處所的所有門窗必須保持關閉；
- (e) 晚上 11 時至翌日上午 9 時，任何人均不得在處所 6 樓及 7 樓的露台逗留；及
- (f) 在任何同一時間內，店舖的總人數連同職員在內，不得超過 160 人在 6 樓及 140 人在 7 樓。

Liquor Licence

Agreed to issue a 6-month liquor licence with the amendment of existing additional licensing conditions as follows:

- (a) No music shall be played and no other sound amplification shall be switched on outside the interior of the premises between 11:00 p.m. and 9:00 a.m. the following day;
- (b) CCTV with recording facilities which cover the common area of the premises and entrance of both male and female toilets shall be installed. The positioning of the CCTV system at the entrance of the male and female toilets shall not infringe the privacy of any person within or using the toilet. All CCTV records shall be kept for at least one calendar month and be available for Police inspection as and when required;

and the imposition of the following additional licensing conditions:

- (c) The licensee shall be on duty on the premises between 9:00 p.m. and 5:00 a.m. the following day except Sunday which is the weekly day off;
- (d) The licensee shall with due diligence ensure that no person smoke or carry a lighted cigarette, cigar or pipe on the premises; and

The other existing additional licensing conditions on the liquor licence remain unchanged.

<p>JB Live</p> <p>Application for New Issue of Liquor Licence</p>	<p>(i) Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <p>(a) The licensee shall be on duty on the premises between 9:00 p.m. and 5:00 a.m. the following day except Monday which is the weekly day off;</p> <p>(b) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; and</p> <p>(ii) The dancing endorsement will only be granted subject to the confirmation by the Fire Services Department that the premises are in compliance with the fire services requirements with the imposition of the following additional licensing condition:</p> <p>(c) No more than 146 persons, including staff, shall be permitted on the premises at any one time.</p> <p>(Since the premises are currently issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>
<p>Big Jo's</p> <p>Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence.</p> <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>
