**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
<b>Ilan</b> Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence.
<b>Nepal Restaurant &amp; Bar</b> Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions.
<b>Fish &amp; Chick</b> 酒牌續期申請	同意續發為期 12 個月的酒牌，並維持酒牌上原有的附加持牌條件。
<b>Metropolitan</b> Application for Renewal of Liquor Licence	Agreed to issue a 12-month liquor licence with the amendment of an existing additional licensing condition as follows:  The licensee shall ensure that no person consumes liquor at the main entrance area of the premises situated between the folding gate and the inner door between 11:00 p.m. and 9:00 a.m. the following day; and  The other existing additional licensing conditions on the liquor licence remained unchanged.
<b>Billiard Restaurant Bar</b> 酒牌轉讓及續期申請	(i) 同意批准酒牌轉讓申請；及  (ii) 同意續發為期 12 個月的酒牌，並維持酒牌上原有的附加持牌條件。

<p><b>MISS</b></p> <p>酒牌續期申請</p>	<p>同意續發為期 12 個月的酒牌，除維持酒牌上原有的附加持牌條件外，並附加下列持牌條件：</p> <ul style="list-style-type: none"> <li>(a) 持牌人須盡應盡的努力確保處所內無人吸煙或攜帶燃著的香煙、雪茄或煙斗；及</li> <li>(b) 持牌人須在牌照的屆滿日期當日或之前參加及修畢酒牌局自 2014 年 1 月 1 日後舉辦的酒牌研討會，並取得酒牌局發出的出席證書。在任何時間，在酒牌局或警務處處長或任何代酒牌局/警務處處長行事的公職人員要求下，持牌人須將該出席證書交出查閱。此外，持牌人須在牌照的屆滿日期之前向酒牌局提交出席證書副本，用以支持牌照續期申請(如有的話)。</li> </ul>
