Liquor Licensing Board's Decision on Open Hearing Cases

Chateau Zoobeetle Application for New Issue of Liquor Licence	Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions: (a) All doors and windows of the premises shall be kept closed between 6:00 p.m. and 9:00 a.m. the following day; (b) No liquor shall be sold or supplied for consumption on the premises between 9:30 p.m. and 9:00 a.m. the following day; (c) No consumption of liquor on the premises shall be allowed between 10:00 p.m. and 9:00 a.m. the following day; (d) No sound amplification device or TV shall be switched on and no music shall be played on the premises between 10:00 p.m. and 9:00 a.m. the following day; and (e) The licensee shall with due diligence ensure that liquor sold or supplied for consumption on the licensed area is to be consumed inside the licensed area only. (The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional Light Refreshment Restaurant Licence (PLRRL), the Board will first issue a liquor licence with an expiry date being the same as the PLRRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)

Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period.)</p>
