**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>EL LOCO GRINGO</b> Application for New Issue of Liquor Licence	Agreed to issue a 9-month liquor licence with the imposition of the following additional licensing conditions:  (a) Not more than 71 persons (0 person for G/F and 71 persons for Lower G/F), including staff, shall be permitted on the premises at any one time;  (b) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day;  (c) No liquor shall be sold or supplied for consumption on the premises between 1:00 a.m. and 9:00 a.m.; and  (d) The rear doors of the premises shall not be used between 11:00 p.m. and 9:00 a.m. the following day, except in case of emergency.  ( The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)

<p><b>金旺角卡拉 OK 夜總會</b> <b>GOLDEN MONGKOK KARAOKE NIGHT CLUB</b> 酒牌轉讓及續期申請</p>	<p>(i) 同意批准酒牌轉讓申請； (ii) 同意續發為期 9 個月的酒牌，並修訂原有的附加持牌條件及附加新持牌條件如下：</p> <ul style="list-style-type: none"> <li>(a) 持牌人須在牌照的屆滿日期當日或之前參加及修畢酒牌局自 2014 年 1 月 1 日後舉辦的酒牌研討會，並取得酒牌局發出的出席證書。在任何時間，在酒牌局或警務處處長或任何代酒牌局/警務處處長行事的公職人員要求下，持牌人須將該出席證書交出查閱。此外，持牌人須在牌照的屆滿日期之前向酒牌局提交出席證書副本，用以支持牌照續期申請(如有的話)；<b>(修訂)</b></li> <li>(b) 處所須在其內的公用地方及房間內裝設附錄影設施的閉路電視，而所有閉路電視錄影帶須保留最少 1 個月，供警方在有需要時可即時查看；<b>(新增)</b></li> <li>(c) 持牌人須確保處所內無人吸煙或攜帶燃着的香煙、雪茄或煙斗；<b>(新增)</b>及酒牌上其餘原有的附加持牌條件則維持不變。</li> </ul>

<p>太平洋酒吧 <b>BAR PACIFIC</b> 酒牌續期申請</p>	<p>同意續發為期 9 個月的酒牌，並修訂原有的附加持牌條件如下：</p> <p style="padding-left: 40px;">處所須在其內的公用地方裝設附錄影設施的閉路電視，而所有閉路電視錄影帶須保留最少 1 個月，供警方在有需要時可即時查看；及</p> <p>酒牌上其餘原有的附加持牌條件則維持不變。</p>
