**Liquor Licensing Board's Decision on Open Hearing Cases**

<b>個案</b> <b>Case</b>	<b>酒牌局的決定</b> <b>Liquor Licensing Board's Decision</b>
<b>好掂</b> <b>The Den</b> Application for Renewal of Liquor Licence	Agreed to issue a 6-month liquor licence with the amendment of an existing additional licensing condition as follows:  No person shall be allowed to stay on the licensed area outside the doors and windows of the premises between 9:00 p.m. and 9:00 a.m. the following day; and  The other existing additional licensing conditions on the liquor licence remained unchanged.  ( Since the premises are currently issued with a Provisional General Restaurant Licence (PGRL), in accordance with the existing policy, the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a liquor licence for the remaining approved period. )
<b>Penthouse</b> 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件：  (a) 在任何同一時間內，店舖的總人數連同職員在內，不得超過 215 人；  (b) 晚上 11 時至翌日上午 9 時，處所的所有門窗必須保持關閉；及  (c) 持牌人須盡應盡的努力，確保晚上 11 時至翌日上午 9 時，不會在露台售賣或供應酒類飲品，亦不會容許任何人在露台飲用酒類飲品。

<p><b>Deligator</b> Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> <li>(a) All doors and windows of the premises shall be kept closed between 10:00 p.m. and 9:00 a.m. the following day;</li> <li>(b) The licensee shall ensure that liquor sold or supplied is to be consumed on the premises only;</li> <li>(c) No liquor shall be sold or supplied for consumption on the premises between 12:00 midnight and 9:00 a.m.; and</li> <li>(d) No consumption of liquor shall be allowed on the premises between 1:00 a.m. and 9:00 a.m.</li> </ul> <p>( The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period. )</p>
