Liquor Licensing Board's Decision on Open Hearing Cases

個案 Case	酒牌局的決定 Liquor Licensing Board's Decision
A Side & B Side 新酒牌申請	同意簽發為期 12 個月的酒牌，並附加下列持牌條件： (a) 下午 6 時至翌日上午 9 時，處所的所有門窗必須保持關閉； (b) 晚上 10 時至翌日上午 9 時，不得容許任何人在處所內飲用酒類飲品； (c) 晚上 10 時至翌日上午 9 時，處所內不得將擴音設備或電視機開著，也不得演奏或播放音樂；及 (d) 持牌人須盡應盡的努力，確保售賣或供應的酒類飲品只供顧客於處所內飲用。 (由於有關處所目前只持有暫准小食食肆牌照，按現行政策，本局會先行簽發一個與暫准小食食肆牌照相同有效期的酒牌。待處所再獲發有效食肆牌照後，才安排簽發餘下期限的酒牌。)
Chez Moi 會社酒牌續期申請	同意續發為期 6 個月的會社酒牌，並維持會社酒牌上原有的附加持牌條件。

<p>Graffiti Application for Renewal of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the retention of existing additional licensing conditions and the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) Not more than 99 persons, including staff, shall be permitted on the premises at any one time; and (b) The licensee shall ensure that no person smoke or carry a lighted cigarette, cigar or pipe on the premises.
<p>Spicy Fingers Bar & Restaurant Application for New Issue of Liquor Licence</p>	<p>Agreed to issue a 12-month liquor licence with the imposition of the following additional licensing conditions:</p> <ul style="list-style-type: none"> (a) All doors and windows of the premises shall be kept closed between 11:00 p.m. and 9:00 a.m. the following day; (b) No speaker or sound amplification device shall be switched on outside the premises or facing the outside of the premises between 11:00 p.m. and 9:00 a.m. the following day; (c) No liquor shall be sold or supplied for consumption on the G/F of the premises between 5:00 a.m. and 9:00 a.m.; and (d) No liquor shall be sold or supplied for consumption on the 1/F of the premises between 1:00 a.m. and 9:00 a.m. <p>(The premises have not yet been granted a valid restaurant licence. In accordance with the existing policy, the liquor licence will only be issued subject to the issue of a valid restaurant licence. If the premises are then issued with a Provisional General Restaurant Licence (PGRL), the Board will first issue a liquor licence with an expiry date being the same as the PGRL. Subject to further issue of a valid restaurant licence in respect of the premises, the Board will issue a further liquor licence for the remaining approved period.)</p>

- (i) Refused application for deletion of additional licensing conditions;
- (ii) Agreed to issue a 2-year liquor licence with the amendment of existing additional licensing conditions as follows:
- (a) No liquor shall be sold or supplied for consumption on the premises between 6:00 a.m. and 9:00 a.m.;
- (b) Not more than 101 persons, including staff, shall be permitted on the premises at any one time;
- and the imposition of the following additional licensing condition:
- (c) CCTV with recording facilities which cover the common area of the premises shall be installed, and all CCTV records shall be kept for at least 14 days and be available for Police inspection as when required; and
- The other existing additional licensing conditions on the liquor licence remained unchanged.
